Ajay Bisaria has been the High Commissioner of India to Canada from March 1, 2020. Ajay was Private Secretary to the Prime Minister Atal Bihari Vajpayee from 1999 to 2004.

He is a career diplomat who joined the Indian Foreign Service in 1987. Over his career he has served in several Indian Embassies and Ministry of External Affairs positions through Russia, Eurasia, Europe and Pakistan.
